I've had contact with CIA and am attempting to get them to share a site license or equivalent for TeamViewer so that we stay within their service strategy that uses TeamViewer. There are works-around to allow CIA to access if we decide to use a different remote access method. Awaiting resolution from CIA.

A motion was made and seconded to authorize Kirschman and Puller to purchase a 2 year license for the RemotePC software after other avenues of corrective action have been exhausted.
